

WARRANTY

Bobcat Compact Tractor

Bobcat Company warrants to its authorized dealers and authorized dealers of Bobcat Equipment Ltd., who in turn warrant to the owner, that each new Bobcat Compact Tractor will be free from proven defects in material and workmanship with respect to (i) all components of the product except as otherwise specified herein for twenty four (24) months or 1500 hours (whichever occurs first), (ii) the powertrain components consisting of clutch housing, transmission case, differential and final drive housing and all parts contained therein plus the drive axles and external driveshafts, and the engine components consisting of the crankcase, cylinder head, front gear case, valve cover pans and all parts contained therein but not including fuel, electrical, cooling, intake or exhaust components unless specifically covered under the Emission Control System Warranty for such product, for forty eight months unlimited hours for a tractor sold to a Non-Commercial Customer as specified in the delivery report submitted by the dealer to Bobcat or thirty-six months or 2000 hours (whichever occurs first) for a tractor sold to a Commercial Customer as specified in the delivery report submitted by the dealer to Bobcat, (iii) Bobcat brand tires, for twelve (12) months on a prorated basis based on the remaining depth of the tire at the time any defect is discovered, (iv) Bobcat brand batteries, for twelve (12) months with an additional twelve (12) months provided that Bobcat Company shall only reimburse a fixed portion of the cost of replacing the battery during such additional twelve months and (v) Bobcat accessories that are factory installed for a period of twelve (12) months. The foregoing time periods shall all commence after delivery by the authorized Bobcat dealer to the original buyer.

During the warranty period, the authorized Bobcat dealer shall repair or replace, at Bobcat Company's option, without charge for parts and labor, any part of the Bobcat product except as otherwise specified herein which fails because of defects in material or workmanship. The owner shall provide the authorized Bobcat dealer with prompt written notice of the defect and allow reasonable time for repair or replacement. Bobcat Company may, at its option, require failed parts to be returned to the factory. Travel time of mechanics and transportation of the Bobcat product to the authorized Bobcat dealer for warranty work are the responsibility of the owner. The remedies provided in this warranty are exclusive.

This warranty does not apply to tires (except Bobcat brand tires). The owner shall rely solely on the warranty, if any, of the respective manufacturers thereof. This warranty does not cover replacement of scheduled service items such as oil, filters, tune-up parts, and other high-wear items. This warranty does not cover damages resulting from abuse, accidents, alterations, use of the Bobcat product with any accessory or attachment not approved by Bobcat Company, air flow obstructions, or failure to maintain or use the Bobcat product according to the instructions applicable to it.

THIS WARRANTY IS EXCLUSIVE AND IN LIEU OF ALL OTHER WARRANTIES AND CONDITIONS, EXCEPT THE WARRANTY OF TITLE AND THE EMISSION CONTROL SYSTEM WARRANTY FOR THE PRODUCT. BOBCAT COMPANY DISCLAIMS ALL OTHER WARRANTIES AND CONDITIONS, EXPRESS OR IMPLIED, INCLUDING ANY IMPLIED WARRANTIES OR CONDITIONS OF MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE. IN NO EVENT SHALL BOBCAT COMPANY OR THE AUTHORIZED BOBCAT DEALER BE LIABLE FOR ANY SPECIAL, INCIDENTAL, INDIRECT OR CONSEQUENTIAL DAMAGES WHATSOEVER, INCLUDING, BUT NOT LIMITED TO, LOSS OR INTERRUPTION OF BUSINESS, LOST PROFITS, OR LOSS OF MACHINE USE, WHETHER BASED ON CONTRACT, WARRANTY, TORT, NEGLIGENCE, STRICT LIABILITY, STATUTE OR OTHERWISE, EVEN IF BOBCAT COMPANY OR THE AUTHORIZED BOBCAT DEALER HAS BEEN ADVISED OF THE POSSIBILITY OF SUCH DAMAGES. Kioti Tractor Division as the holder of the U.S. Environmental Protection Agency (U.S. EPA) Certificate of Conformity and California Executive Order for the vehicle. The emission control limited warranty is in addition to the standard limited warranty for your vehicle.

CONSUMER WARRANTY RIGHTS & OBLIGATIONS

INTRODUCTION

Daedong-USA INC. Kioti Tractor Division (KIOTI) is pleased to explain the emission control system warranty on your 2019 model year engine designed & manufactured to meet the stringent requirements of Tier IV.

In North America, new engines must be designed; built and equipped to meet the EPA's reduced emission standards & California's stringent anti-smog standards.

KIOTI must warrant the emission control system on your engine for the periods of time listed below provided there has been no abuse, neglect or improper maintenance of your engine.

Additional conditions and responsibilities are further outlined below. Where a warrantable condition exists, KIOTI will repair your engine at no cost to you including diagnosis, parts and labor.

The warranty period shall begin on the date the engine is first placed in service (Date of sale).

This emissions warranty is applicable in all provinces, states and territories of the United States of America and complies with the policies of Federal Warranty Provisions. This warranty is also applicable in all provinces & territories of Canada.

MANUFACTURER'S WARRANTY COVERAGE:

KIOTI warrants to the original owner, and to each subsequent owner, of a new, diesel engine that the emission control system of your engine:

1. Was designed, built and equipped so as to conform at the time of sale with all applicable regulations of the EPA and CARB.

2. Is free from defects in material and workmanship which will cause such engine to fail to conform with applicable regulations for the following warranty period:

• For variable speed engines rated less than 19 kW (25 HP), excluding UTV's:

- Commercial application: Three (3) years or 2,000 hours of operation, whichever occurs first.

- Non-Commercial application: Four (4) years

• For all other variable speed engines rated at or above 19 kW (25 HP):

- Commercial application: Five (5) years or 3,000 hours of operation, whichever occurs first.

- Non-Commercial application: Five (5) years

The emission control systems of your new Daedong engine were designed, built and tested using genuine Daedong parts, and the engine is certified as being in conformity with EPA and CARB emission control regulations.

Accordingly, it is recommended that any replacement parts used for maintenance, repair or replacement of emission control systems be genuine Daedong parts.

Owners may choose to use any replacement part in the performance of any maintenance or non-warranty repairs although KIOTI recommends that the owner obtain assurance that such parts are warranted by their specific part manufacturer to be equivalent to genuine Daedong parts.

Any warranted part which is not scheduled for replacement as required maintenance shall be warranted for the warranty period defined above.

If any such part fails during the period of warranty coverage, it will be repaired or replaced under warranty. Any such part repaired or replaced under the warranty shall be warranted for the remaining warranty period.

Any warranted part which is scheduled only for regular inspection in the written instructions shall be warranted for the warranty period defined above.

A statement in the written instructions to the effect of "repair or replace as necessary" shall not reduce the period of warranty coverage.

Any such part repaired or replaced under warranty shall be warranted for the remaining warranty period.

Any warranted part which is scheduled for replacement as required maintenance shall be warranted for the period of time prior to the first scheduled replacement point for that part.

If the part fails prior to the first scheduled replacement, the part shall be repaired or replaced by the engine manufacturer under warranty.

Any such part repaired or replaced under warranty shall be warranted for the remainder of the period prior to the first scheduled replacement point for the part.

Repair or replacement of any warranted part under warranty shall be performed at no charge to the owner at an authorized KIOTI warranty station.

KIOTI provides warranty services or repairs at all manufacturer distribution centers (warranty stations) that are franchised to service the subject engines. Please see the Customer Assistance section of this statement for help in locating such service centers.

The owner will not be charged for diagnostic labor that leads to the determination that a warranted part is in fact defective, provided that such diagnostic work is performed at an authorized KIOTI warranty station.

KIOTI is liable for damages to other engine components caused by the failure of a warranted part remaining under warranty.

KIOTI is required by EPA and CARB regulations to maintain a supply of parts sufficient to meet the expected demand for such parts during the warranty period for the engines covered by this warranty.

OWNER'S WARRANTY RESPONSIBILITIES:

This engine is designed to operate on ultra low sulfur fuel only. Use of any other fuel may result in this engine no longer operating in compliance with applicable emissions requirements.

The purchaser is responsible for initiating the warranty process by presenting the engine to an authorized KIOTI Warranty Station, as soon as a problem exists. The warranty repairs should be completed by the dealer as expeditiously as possible.

Use of any add-on, modified or non-KIOTI approved or equivalent replacement parts may reduce or eliminate your warranty coverage. The use of any non-approved, add-on or modified parts shall be grounds for disallowing a warranty claim. KIOTI is not liable for warranty failures of warranted parts caused by the use of a non-approved, add-on or modified part.

The emissions control parts covered by this Emission Control System Warranty are listed under "What is covered by the Emission Warranty." You are responsible for the performance of all scheduled maintenance or repairs on your new Daedong engine.

KIOTI may deny a warranty claim if your failure to perform maintenance results in the failure of a warranted part. Receipts covering the performance of regular maintenance should be retained in the event questions arise concerning maintenance. The receipts should be transferred to each subsequent owner of the equipment with the emission warranted engines.

WHAT IS NOT COVERED BY THE EMISSION WARRANTY

This warranty does not cover:

1. Malfunctions in any part caused by any of the following: misuse, abuse, improper adjustments, modifications, alteration, tampering, disconnection, improper or inadequate maintenance, or use of fuels not recommended for the engine as described in the Owner's Manual.
2. Damage resulting from accident, acts of nature or other events beyond the control of Manufacturer.
3. The replacement of expendable maintenance items such as exhaust system, filters, hoses, belts, oil, thermostat, and coolant made in connection with scheduled maintenance services once these parts have been replaced.
4. Replacement items which are not genuine Daedong parts or not authorized or approved by **KIOTI** in writing.
5. Loss of time, inconvenience, loss of use of equipment, engine or commercial loss.

WHAT IS COVERED BY THE EMISSION WARRANTY**IMPORTANT**

- This may not include expendable maintenance items such as nozzle assemblies and rubber angles.
- Emission related parts requiring scheduled maintenance are warranted until their first scheduled replacement point only.

During the warranty period, the authorized Bobcat dealer shall repair or replace, at Bobcat Company's option, without charge for parts and labor, any part of the Bobcat product which fails because of defects in material or workmanship. The owner shall provide the authorized Bobcat dealer with prompt written notice of the defect and allow reasonable time for replacement or repair. Bobcat Company may, at its option, require failed parts to be returned to the factory. Travel time of mechanics and transportation of the Bobcat product to the authorized Bobcat dealer for warranty work are the responsibility of the owner. The remedies provided in this warranty are exclusive.

This warranty does not cover replacement of scheduled service items and high wear items. The owner shall rely solely on the warranty, if any, of the respective manufacturers thereof.
